CCROA PRESIDENT'S REPORT-MAY, 2014

Greetings!! As CCROA President, the past 8 months have been challenging and rewarding. As Lake Rep and member of the Invasive Species Task force, I was familiar with those areas and have attended many seminars, meetings & conferences regarding Invasive Species. The Cisco Chain Dam purchase has been challenging. I would like to say "Thanks" to Kully Rohlen, Past-President for his guidance.

The top questions from the CCROA membership are:

- 1. What's going on with the Dam purchase and are we still going to be able to buy the Dam?
- 2. What's taking so long?

In January we learned that the UPPCO asset of Integrys was being sold to Balfour Beatty PLC. Yes, we still will be able to purchase the Dam, but it might take some time yet. The protracted timeline that has frustrated us all has resulted from the process of removing the Dam from the FERC license which would clear the way for us to purchase the Dam.

Two years ago there was an intensive effort to establish a Dam fund and raise capital with a sense of urgency. The purpose of that was to generate sufficient funds to demonstrate at that point on the timeline of action, that we were a serious candidate to purchase and meet ongoing financial obligations as prospective owners of the Dam. The entire process has been extremely complex and many resource agencies and public input weighed in with their respective concerns.

A few of the resource agencies are The US Forest Service, the Wisconsin DNR and the Michigan DNR. Each agency is advisory in nature but their input is part of the comprehensive data that will be considered by FERC in arriving at a decision. Examples of their concerns are water levels on the chain and their effects on outflow into the Middle Branch of the Ontonagon River and the resulting impact on the river's ecosystem. Page 2

This is only a small example of the myriad of input gathered during the ongoing process. Additionally, there is language in the present licensing agreement that has caused considerable dialogue and brainstorming in order to meet the requirements in a cost effective and practical way.

So where does all this leave us right now? The sale of UPPCO to Balfour does not appear to have any negative impact on the process underway. The process is moving forward and is in the hands of FERC. We patiently continue to wait for their decision. Any news or updates of importance will be immediately sent out via email blast. This leads me to the next topic.

I am committed to keeping the membership current on CCROA news. In order for you to get the most up to date news in a timely fashion it is important for the CCROA to have your email address. Examples of important information are the upcoming road work on Thousand Island Lake Road and the Lindsley Bridge (see page 4), AIS lake treatment information and important event reminders. Please make sure we have email contact information for every member of your family that wishes to receive these important emails. I wish to stress that your email address WILL NOT be shared with anyone else or used for any other purpose than occasional distribution of important CCROA news and electronic editions of Shorelines.

An additional source of information is the CCROA web site. It is updated regularly so please log on and visit it for the most current information about The Cisco Chain. Two upcoming events of importance are the Annual Business Meeting scheduled for Thursday July 17th and the Annual Association Picnic on Sunday July 20th. If you have not marked your calendar already please do so now. I look forward to seeing you at both events! *Greg Wewzel*

Invasive Species Update -MAY, 2014

With spring here, (finally!) our invasive species abatement program gets into motion. I wanted to take a moment to update you on our plans for 2014. This year we will continue to focus our attention on the three lakes where Eurasian Water Milfoil (EWM) has been identified- Clearwater, Thousand Island, and Big Lakes.

The big news for 2014 will be our whole-lake treatment for Clearwater Lake. This year we will be using a new chemical, fluridone, which when used in very small concentrations, treats the entire body of water leaving EWM nowhere to hide. 2014 will be the first year in a three year process. Years two and three will see a return to a more conventional spottreatment use of 2,4-D to kill any EWM which may have survived the fluridone treatment. This process, while expensive, comes with an 80% reduction in EWM guarantee.

Thousand Island Lake will undergo another EWMspecific survey by Many Waters. We expect to find EWM along the north shore and also the eastern shore by the boat launch. Any areas deemed as candidates for treatment will be treated with 2,4-D by Property Land Management (PLM), the same company which will be administering the Clearwater Lake treatment. Any areas of EWM will be marked with our orange marker buoys. Please remain clear of any orange buoys as one of the ways EWM is spread is by having pieces broken off (by props or fishing lures) and having that fragment drift, settle, and take root in a new location.

Big Lake will be surveyed by Northland College and any treatable areas will be treated with 2,4-D, again by PLM. Last year, our initial survey did not locate any treatable areas. Only after the window for treatment was past were we able to locate the EWM beds. We expect to find EWM along the southern and eastern shore along with an area north of the DNR boat launch. As on Thousand Island Lake, orange buoys will mark the EWM so please avoid them.

This year we are continuing our Invasive Species Abatement fundraising. You may have already received our letter in the mail. Please take a moment and consider a tax-deductible donation to this very important project. Your Association is diligently working to keep the Cisco Chain pristine for your enjoyment as well as that of others.

Consider the impact on our lakes if we were unable to fund the fight against EWM. The lakes would become choked and unnavigable. Native plants and fish would perish. Property values would fall. We have seen the impacts on other lakes. Fortunately, the CCROA has a membership that is active and understands the costs of inaction as evidenced by the dam purchase fund raising. If each member would donate only \$100, we would reach our goal of \$40,000! Please give thoughtful consideration and help us fund the fight.

We are looking forward to another summer on the chain and continued success against EWM. See you on the lakes!

JAPANESE BARBERRY-TERRESTRIAL INVASIVE By: CCROA Collaboration

Japanese barberry was introduced as a landscape plant approximately 100 years ago. It is a sturdy shrub that tolerates wet as well as dry conditions; HOWEVER, it is very invasive and is listed on the invasive species list for many states including Michigan. As with many invasive species, it has no natural enemies. Deer tend to avoid it.

Barberry spreads quickly, taking over the floor of the woods killing off our natural plants. This impacts the wildlife. The Japanese barberry produces red seeds that show in summer and drop and spread in the fall.

Researchers have found that ticks that carry Lyme disease are prevalent in the barberry. Many requests have been made for nurseries to stop selling Japanese barberry, unfortunately many still do. It is important to eradicate this plant. The use of Round Up is the recommended way to eradicate this plant. Small plants can be dug up, but do so carefully. The plant has nasty sharp thorns.

The Maplewood area on 1000 Island Lake South is currently doing battle with this problematic plant.

ROAD WORK & CLOSURES ON THE CISCO CHAIN

Thousand Island Lake Road contains 67 culverts along its length and all are in need of replacement. Gogebic County Road Commission has scheduled the replacement of 12 of those culverts requiring road closures with a detour weekdays with access allowed during the weekend. This year work will occur from north of the Sylvania Wilderness main access up to Crooked Lake Road.

Thousand Island Lake Road will have closures Monday thru Thursday of the weeks that the culverts are being replaced, opening for Fri-Sun for thru traffic. Gogebic County does not know the frequency of these closures nor have they determined the detour route; however, Gogebic County will be informing Watersmeet Township, CCROA, and the news media when work is scheduled.

Emergency services will be notified prior to the closures, to allow alternate response in a most timely manner.

This is the first year of a multi-year project that will progress as funding allows. Expect delays and extended travel times. Again, your patience is appreciated.

The Cisco dam has been wide open since April 17th. All gates are open. Currently the water is about 6" above the normal level for mid-summer. Use caution while navigating; there might be floating logs & hidden stumps.



The Lindsley Bridge is in need of repairs including replacement of the guard rails, expansion joints, approaches, and repair to the support pilings. This is being done in an effort to extend the life of the bridge 10-15 years before replacement is required.

Work this year will mostly involve engineering surveys and assessments with the actual rehab tentatively scheduled to occur after July 4 through September, 2015. During construction, expect single-lane traffic over the bridge with a temporary signaling device at both ends of the bridge. Boat traffic under the bridge may be reduced to singlelane also. Please be careful and courteous to crews working as well as neighbors trying to pass while work is being done.

HELP PROTECT THE SHORE LINES & CHANNELS

Erosion damage to our shore lines and channels by boat wake is something all of us can help prevent. By reducing boat wake in the channels and near the shore, we all can all help to preserve and protect the shores and channels of the Cisco Chain.

Shore line erosion damage has many consequences such as habitat destruction (our loon nesting areas), increasing sedimentation and turbidity of the water, the release of nutrients that promote algae blooms and loss of land which could potentially affect property values.

The pictures are examples of boat wakes for 3 different speeds of a boat.

- 1. The Displacement speed is the slowest (similar to no wake) bow is down in the water.
- 2. The Transition speed produces the largest wake and is the result of the bow in a high position and the stern plowing through the water.
- 3. The Planing speed (when the boat is planed out) is usually a higher speed. It creates less of a wake than the transition speed but more than displacement speed.
