President's Report

Spring has sprung! It seems more like spring has sprung a leak at the moment I am drafting this report. We have had rain, rain and more rain with minimal relief in sight for the week ahead. Hopefully by the time you receive this we will be enjoying sunny relaxing days here in one of the most beautiful places on the earth!

The February announcement by the Federal Energy Regulatory Commission (FERC) to release the Cisco Dam from their license cleared the way for us to purchase it. Efforts have resumed in that direction. We have met with our attorneys, UPPCO, MDEQ and the Michigan State Dam Inspector. This issue languished on a desk at FERC for four years. Although we have an executed offer to purchase the Dam from UPPCO, much has changed in the past four years, and we are going to move forward slowly and methodically to make sure we do it right! Your continued patience is appreciated as we work through the process.

In regard to the fruit of our efforts to secure grants, we have been awarded a \$10,000 RAC Grant through the USFS. Additionally we have modified a previous grant under that umbrella of Great Lakes Restoration Initiative (GLRI) money to make available monies over an expanded time frame. Preliminary federal budget projections by President Trump call for defunding GLRI by approximately 850 million dollars. This poses a substantial negative impact on our ongoing AIS efforts if it comes to pass. We were just awarded a bit over \$13,000 from a Bond Falls Implementation Team grant. We will continue to utilize allocated funds from the State of Michigan Grant awarded last year in collaboration with numerous partners in the Western UP this summer. All this funding is directed toward lake management. This is indeed good news, but please keep in mind, that these grants all require match funds that mandate we allocate resources in both cash and in-kind hours by volunteers from the CCROA. Consider this thoughtfully when responding to the recent request for donations to our Lake Management fund.

I will complete my fourth year as President of the CCROA at the end of July. As of July 31st I will retire as President due to health concerns. It has been a privilege to champion

our beloved Cisco Chain of Lakes and lead the organization forward. I appreciate the support from the board and members of the association during the past four years as president and two previous years as a Lake Representative. Bob McGuffin, our Vice President will fill my position and I can assure you he has played a leadership role in this organization far more than most people realize! I will continue to support ongoing efforts and future initiatives.

Lastly, two initiatives that focus on the importance of shoreline protection, preservation and restoration have been undertaken. The first is the distribution of a door hanger packet of information that is being delivered to every home on the Chain. Please take the time to look through the material and learn if there are any components of the outreach that might apply to managing a healthy shoreline on your property. Secondly, the Michigan State University Extension, Natural Shoreline Partnership will present a workshop on July 28th, 2017 in Watersmeet. The CCROA board will reimburse members the \$ 40 early registration fee upon completion of the class. Members are highly encouraged to attend this great educational opportunity. More info on the workshop and registration is on page 4 in this edition of *Shore Lines*.

Did You Know????

In Michigan, any construction or land clearing within 500 feet of any water body or any construction area larger than one acre in size, requires a Soil Erosion and Sediment Control (SESC) Permit before a Building Permit can be issued, as per State law. This program is designed to require erosion control techniques to reduce soil erosion and prevent sedimentation of lakes and streams through the issuance of a SESC permit and conducting site inspections to insure compliance.

What this means is that **BEFORE** Watersmeet Township can issue you a building permit, you first have to secure your SESC permit from Gogebic Conservation District and Gogebic County Soil Erosion and Sediment Control Enforcing Agencyas required by state law.

While the township may issue you your building permit WITHOUT this SESC permit, this does not relieve you of the requirement to obtain this SESC permit before construction begins. This permit typically cost \$150/acre of disturbance, but will double if work begins before a permit is issued.

In addition to SESC permitting, this site also is a great resource for information on terrestrial invasive species, native shrubs for wildlife habitat, and an annual tree and shrub sale which would be excellent for shoreline restoration projects!

To aid in the battle against terrestrial invasive plant species, the CCROA has purchased both an Uprooter and a Mini Uprooter. These tools are for use by CCROA members. Contact Greg Wenzel in order to do so. For more information, visit www.ciscochainroa.com.



I am very happy to report that we have finally received a permit to treat for Eurasian Water Milfoil (EWM) on Big Lake! After several frustrating years, we will be treating nearly 10 acres of EWM on the south and east end of the lake. This is very good news and took far more effort than should have been necessary. In the end, your Association had to appeal to the highest levels of the Wisconsin Department of Natural Resources (WDNR) and the Wisconsin Natural Resource Board (WNRB). We are anxious to get started working on the long-standing EWM colonies here using every tool at our disposal- chemical treatment of large areas as well as physical removal of smaller stand-alone plants. We are hoping to have the same success we have experienced on the north end of Thousand Island Lake.



While the treatment on Big Lake is the big news, it certainly isn't the only work we will be doing this year in support of our Aquatic Invasive Species (AIS) abatement program. We have permits secured to treat Morley, Lindsley, and Thousand Island Lake in 2017. Our spring surveys will dictate our course of action here. The larger colonies will be treated and the smaller areas will be either hand-pulled by divers or physically removed by use of Diver Assisted Suction Harvesting (DASH).

By now, you should have received my annual AIS fundraising letter. If you have already donated to this critical program we thank you. If you have not, please take the time to consider making a tax-deductible donation to this important program. Your Association simply cannot fund this program without the support of our membership. Donating can be done with either a check in the mail or online through our website www.CiscoChainROA.com and clicking on the "Donations" button in the lower right-hand corner.

We are very excited to get started on Big Lake. This year will be the culmination of a huge effort by your Board and biologists from Many Waters LLC. While eradication of the EWM is not a reasonable goal, control is. Managing EWM, now that it is here, will be a continuing on-going effort for us. As always, I- as well as your entire Board- appreciate your support! Thank you and see you on the water!

NATURAL SHORELINE WORKSHOP - JULY 28, 2017

Michigan State University Extension is presenting a Natural Shoreline Workshop right here in Watersmeet on July 28, 2017!!!! Natural shorelines on inland lakes are not only beautiful, they also provide numerous benefits keeping the lake healthy, reducing shoreline erosion and run off into the lake plus providing essential habitat for plants and animals.

The Workshop will be held at Lac Vieux Desert Resort and Casino on July 28, 2017 from 9:30 am to 5 pm. Registration is \$40 per person on or before July 6, 2017 or \$60 per person on or after July 7, 2017. Advance reservation is recommended

The registration fee includes lunch, workshop handouts and the MSUE *Natural Shoreline Landscapes on Inland Lakes Guidebook* (A \$25 value). Registration is done online at

At the workshops you will learn the benefits of maintaining shorelines in a natural state, and about tools and resources to plan and protect the natural shorelines.

Highway B spring road cleanup was completed by CCROA members Jim Okraszewski and Dan Sauer. Six large bags full of road garbage were picked up and disposed of. The sign near the boat landing identifying CCROA as the organization responsible for clean-up from Thousand Island Lake road to the Helen Creek boat landing was down on the ground - the county was notified. As usual, debris in spring consisted mostly of drink and other food containers. After the summer the debris includes much more garbage that appears to blow out of boats as they are trailered down the road such as styrofoam bait buckets and lids and packaging from baits including worms and artificial baits. Over the years, useable shotgun shells, fishing tackle in working condition and even a valid driver's license (which was returned to the owner) have been found. There is also guite a bit of wreckage from cars and snowmobiles which have had mishaps along the road.

US 2 spring road cleanup - The 2 mile Adopt-A - Highway stretch of US 2 that the CCROA maintains has also been completed by members Paul & Patsy Lucas. Five bags of roadside trash were collected.

Road cleanup is again done in the fall.

SUMMER ROADWORK SCHEDULE

Phase 1 of Thousand Island Road paving will begin June 12th, 2017 and is expected to be completed shortly after July 4th. It will be a 3 mile stretch from US 2 south.

The removal and replacement of 18 culverts for the south portion of Thousand Island Lake Road will begin Monday, June 5th. Road closures will done the same as in the past, opening for weekends.

In the works is final approval for paving 6 miles of Thousand Island Lake Road from Roddis Road north. The work will begin in late fall.

Another project is the removal and replacement of a large culvert and repaving on the Middle Branch of the Ontonagon River.

This summer \$2.2million (grant money and general fund) will be spent for roadwork on the Thousand Island Lake Road project.

As with all road projects, please slow down and be courteous to both the workers and your neighbors who will be trying to navigate these work areas
